

Consultant, Public Health Consulting

The Consultant role within Rabin Martin involves supporting Public Health Programs while honing your skills as a strategic thinker, working across the private and public sector, to positively impact health outcomes. Consultants play a key role in the day-to day program support, stakeholder relations, research and analysis, and creation of multiple client deliverables.

A knowledge of the pharmaceutical industry would be an asset for this role as most of Rabin Martin's clients are large global pharma firms.

Client Services

- Provide clear, concise persuasive writing for a variety of executive audiences. Write, edit, and prepare strategy recommendations, landscape and peer analyses, issue briefs, proposals, and other client deliverables. Analyze and synthesize data and information independently, and present clear, properly formatted documents, emails, and oral and written presentations.
- Conduct key activities such as landscape analysis, stakeholder mapping and stakeholder interviews. Help manage and coordinate relationships with stakeholders from various sectors (government, NGO, corporate, multilateral).
- Conduct research, analyze findings and collate findings into key themes, define key audiences across global settings, and disseminate information.
- Provide strategic counsel, informed recommendations, and ideas for growth to clients. Effectively articulate new ideas to clients and colleagues.
- Actively participate in both client and team meetings. Facilitate internal meetings and client interactions with team support.
- Stays up to date on trends in public health and how it impacts clients and communities.
- The ability to generate documents for client presentations and deliverables that are persuasive, compelling, and require minimal editing and revision.
- Proven ability to make quality recommendations and informed decisions about deliverable creation and project management with input. Identify barriers and obstacles to meeting deadlines and provide workable solutions.
- The ability to present ideas and recommendations to clients and colleagues, as well as participate as a persuasive presenter in client presentations alongside other senior Rabin Martin team members.

- Execute on key deliverables, asks appropriate questions, and uses available resources. Creates timelines to prioritize deadlines and to stay on track.
- The ability to work well under pressure in a way that generates trust internally and with clients and peers, is flexible to changing client and firm needs, and stays positive during unforseen changes

Qualifications

- A bachelor's degree in public health or relevant healthcare or business field at a minimum. A post graduate degree and relevant professional designation such as an MPH, MPA, MSC or MBA is preferred.
- A minimum of 3 years' experience in public health (including field work) and/or with a professional service consulting firm, working to implement effective public health or related initiatives that deliver improved health outcomes and business growth.
- Experience synthesizing research and analysis into structured and logical recommendations.
- Experience in building and maintaining relationships with clients, partners, and engaging with international and national-level public health stakeholders.
- Exceptional analytical, quantitative, and conceptual thinking skills following common management consulting methodologies and tools.
- Demonstrated experience supporting project teams, generating client presentations and deliverables and meeting deadlines.
